

# **Privacy Notice**

This privacy policy sets out how we use any information that you give Lamberts Installations Ltd when you use this website.

Lamberts Installations Ltd is committed to ensuring that your privacy is protected. Should we ask you to provide certain information by which you can be identified when using this website, then you can be assured that it will only be used in accordance with this privacy statement.

#### What we collect
